The content will be rich. Rob Bollo, MD, FAANS, has been working with the Accreditation Council for Pediatric Neurosurgery Fellowships on a session on Wednesday for Fellows to present their research, culminating in awarding the inaugural Molly Hubbard Prize for Fellow Presentation. Andrew Jea, MD, FAANS, is leading the American Academy of Pediatrics-Section on Neurological Surgery event on Thursday, with a special session with Sally Goza, MD, President of the AAP. Haley Vance, Mandy Breedt, Han Nguyen and Andrea Sloane are working to establish an enduring community of advanced practitioners, and will have a full session of informative presentations during a concurrent session on Wednesday. Ann Marie Flannery, MD, FAANS; Jerome Volk, MD; and the New Orleans group will host a session address the racial injustice, the effects of the pandemic on neurosurgery and neurosurgery training, and mission driven philanthropy on Friday. Their session will also include abstracts on hydrocephalus and trauma. Sandi Lam, MD, FAANS, and Brandon Rocque, MD, MS, FAANS, have prepared a Thursday session addressing functional neurosurgery, including a "how-l-do-it" session on dorsal rhizotomy and a talk by John Rogers, PhD, a material science engineer, on novel devices for the treatment of epilepsy. Todd Hankinson, MD, MBA, FAANS, and Paul Klimo, MD, FAANS, will host a Wednesday session on neuro-oncology, including updates from Nalin Gupta, MD, PhD, FAANS, and Kathleen Dorris, MD, as well as an interactive clinical case presentation by Dr. Klimo. There will be a concurrent abstract session on Thursday, led by Ruth Bristol, MD, FAANS, and Elias Rizk, MD, FAANS. We will have opportunities for informal meetings and engagement with exhibitors.

I am grateful for the diligence of Ann Marie Bray, Sue Christiansen, Samantha Luebbering and the AANS meeting staff who have been working with us to plan this year's meeting, and who were able to effect a contractual change with the Grand America Hotel in Salt Lake City to ensure the Pediatric Section did not incur any liabilities or costs for this change.

I'd be remiss if I didn't acknowledge the diligent collaborative work performed by Doug Brockmeyer, MD, FAANS, and the Salt Lake City team up to this point. I am glad to report that they have agreed to host the 50th Annual Meeting of our Section December 7-10, 2021. I know that we will all be looking forward to getting together in person next year.

I'm truly looking forward to "seeing" you all in December. The Pediatric Section needs your support and your engagement. I'm certainly pleased to report that we've had a record number of abstract submissions, and I'm hopeful that with your participation during the meeting, pediatric neurosurgery will emerge from this stronger than ever.

#### TREASURER'S REPORT

Richard C. E. Anderson, MD, FAANS

The Pediatric Section remains in good financial health. Total net assets as per the last (6/30/2020) financial statement totaled \$953,506. This is an increase over the prior year (\$888,285) and continues to reflect a comfortable reserve to support an entire annual meeting plus Section activities for two years without any revenue. Section leadership is prioritizing the use of the extra reserves in a manner consistent with the Section's mission.

#### **Annual Meeting**

The 2019 Annual Meeting for the AANS/CNS Joint Section in Pediatric Neurological Surgery in Scottsdale had a net excess of \$53,867. This is compared to a net excess of \$91,908 at the 2018 Annual Meeting in Nashville. Revenue projections for the upcoming 2020 virtual meeting are currently in flux. The net revenue for meetings has now been positive for more than five years as a result of continued efforts by Section officers to reduce costs in collaboration with local meeting hosts and AANS staff.

#### **Long Term Investments**

Despite the COVID-19 pandemic, the Section's long-term investment account remains favorable at \$834,018. This is an increase from last year at \$807,795. The Section's long-term investments are handled via a pooled investment portfolio with the other sections, which allows the sections to get into funds not otherwise available to smaller investors.

#### **Honor your Mentor Funds**

The A. Leland Albright fund has accumulated \$52,683. The Sanjiv Bhatia fund has accumulated \$56,269.

#### **Specific Expenses and Financial Resolutions**

The Section continues its commitment toward its educational and research missions. In the 2020 budget, there is renewed financial commitment toward the Pediatric Neurosurgical Research & Education Foundation (NREF) Fellowship grant, Section research awards and domestic and international traveling fellowships.

Overall, there appear to be no concerns.

#### NATIONAL MEETINGS COMMITTEE REPORT

The National Meetings Subcommittee is charged with helping to plan the Pediatric Section activities at the American Association of Neurological Surgeons (AANS) and Congress of Neurological Surgeons (CNS) national meetings. We follow recent changes in the field to try to improve the quality and maintain the relevance of lectures and abstracts. The goal is to promote discussions that address timely topics and updates as well as consensus management from experts in the field. The AANS has suggested a number of newer session formats to maximize engagement and interest. These have been incorporated into plans for both the 2020 Joint Pediatric Session meeting and the 2021 AANS Annual Meeting.

The 2021 AANS Annual Meeting is scheduled to will be held in Vancouver, with the Pediatric Scientific Sessions on Monday April 19 and Wednesday April 21. While the current plan is to include live attendance, the sessions are also being planned to include more remote content. This may facilitate the inclusion of a wider breadth of presenters, some of whom may not have travelled to the meeting in previous years. Sessions are being designed to promote attendee participation/interaction with speakers. Some aspects of the sessions may be pre-recorded and some will certainly be live. Both sessions will include abstract presentations.

Currently, the Monday session is planned to include the Matson Lecture (speaker TBD); an update on molecular testing and bio-banking for pediatric brain tumors; an operative technique session regarding epilepsy management; and an interactive discussion between experts regarding a topic in tumor management or spasticity.

The Wednesday session will include a TED-style lecture regarding Neuroethics related to Technological Advances; a complex case presentation/discussion; a session that follows a patient through an acute presentation and management, allowing for interactive discussion; and presentations of particularly influential papers that appeared in the Journal of Neurosurgery this year.

We want to thank everyone participating in the educational and scientific program and look forward to the upcoming meetings.

#### INTERNATIONAL EDUCATION COMMITTEE

During this pandemic, international education efforts have gone virtual. The committee has partnered with the ISPN in supporting its popular "Clash of the Titans" webinar series, with past-chair of our Section, Mark Proctor, MD, FAANS, presenting on craniosynostosis surgery and member Jeff Blount, MD, FAANS, speaking on corpus callosotomy.

The International Education Committee is still working on a web-based survey of section member international education activities, to serve as a resource for members to collaborate their efforts and for those members interested in international education to get advice and mentorship.

#### **GUIDELINES COMMITTEE REPORT**

The Pediatric Section Guidelines Committee has participated in multiple projects over the last six months through zoom meetings and conference calls.

An update of the 2014 Hydrocephalus Guidelines was completed and approved by the Joint Guidelines Review Committee (JGRC) of the AANS/CNS in August. The manuscript to be published in Neurosurgery this fall. Two significant updates were made to the prior guidelines. In chapter two, a level III recommendation was added, stating neuro-endoscopic lavage is a feasible and safe option for the removal of intraventricular clots in post hemorrhagic hydrocephalus in premature infants, and it may lower the rate of shunt placement. In chapter seven, the recommendation for the use of antibiotic impregnated shunt systems was strengthened to level I, based on the recently published prospective, single-blinded, randomized BASICS trial from the U.K.

We are happy that the CNS Guidelines Committee has given us a start date for October to begin the process to create the new Guidelines for the Management of Chiari I Malformation. We plan three chapters that will guide pre-operative work-up, surgical intervention, and treatment of craniocervical junction pathology. With an October 2020 start date, we hope to have the final document ready by fall 2021.

The Pediatric Section is working with the Stereotactic and Functional Section of the AANS/CNS, the American Academy of Neurology (AAN), and the American Epilepsy Society (AES) to create Guidelines for the Surgical Treatment of Epilepsy. Created in summer 2019, the group is currently defining search terms and preparing for abstract and full text review. Final manuscripts will likely be complete in fall 2021.

The Pediatric Section is represented in an upcoming update of the Guidelines for the Diagnosis of Brain Death. The update will unify the adult and pediatric guidelines into one document. A modified Delphi methodology is used, and the third round of voting was recently completed. Final documents should be published in 2021.

Finally, the Pediatric Section is represented in an upcoming guideline on platelet and plasma transfusion in children through the TAXI-CAB initiative through BloodNet and the American Society of Pediatric Hematology / Oncology (ASPHO). The multi-disciplinary group is composed of pediatric intensivists, hematologists, and surgeons. The working group has performed abstract and full text reviews, and it is in the process of creating Grade based guidelines and best practice statements. The guidelines will cover many topics, including transfusion for non-cardiac surgery such as craniosynostosis surgery and transfusion for critically ill pediatric patients with TBI.

#### **ABPNS REPORT**

John Kestle, MD, FAANS (ABPNS Chair) and Bermans J. Iskandar, MD, FAANS (ABPNS Secretary-Treasurer)

The Boards of Directors of the American Board of Pediatric Neurological Surgery (ABPNS) and the American Board of Neurological Surgery (ABNS) continue to refine the new American Board of Medical Specialties (ABMS)approved certification process for pediatric neurosurgeons. After completing the requirements, candidates receive a Recognition of Focused Practice (RFP) in Pediatric Neurological Surgery in collaboration with the ABNS or the Royal College of Physicians and Surgeons of Canada (RCPSC). All neurosurgeons seeking certification or recertification in pediatric neurosurgery should refer to the ABPNS (https://abpns.org) and ABNS (https://www. abns.org) websites for details. Other important highlights can be found in the previous edition of the Pediatric Short Cuts (<a href="https://pedsneurosurgery.org/wp-content/">https://pedsneurosurgery.org/wp-content/</a> uploads/2020/04/Peds-Shortcuts-Spring2020.pdf).

#### **ABNS Oral Exam**

- Six of the 11 ABPNS Directors will serve as examiners at the fall 2020 virtual ABNS oral examination.
- The ABPNS holds occasional oral exam sessions for those seeking the pediatric RFP but did nottake the pediatric-focused ABNS oral exam. This mainly affects RCPSC diplomates seeking the RCPSC-ABPNS RFP, as well as the few ABNS diplomates who did not take the pediatric-focused ABNS oral examination. The next ABPNS oral exam will be held virtually on December 11, 2020.

#### **ABPNS Recertification**

- All ABPNS diplomates who plan to recertify (at the end of 10 years) are required to participate in the ABNS Continuous Certification program (CC). This includes Canadian diplomates (who have now been authorized to take the annual pediatric adaptive learning modules on the ABNS website), and both time-limited and nontime limited ABNS diplomates. Diplomates who do not intend to recertify (i.e., they intend to seek Certified-Retired status) at the end of their 10 years do not need to participate in CC.
- The Board of Directors (BOD) will review ABPNS recertification applicants at its December 2020 meeting.
   The deadline for the ABPNS recertification application submission is October 1, 2020.

#### **Outgoing ABPNS Directors and New Nominations**

 Dr. Kestle will be rotating off the ABPNS BOD in December of 2020. Nominations have been received from the nominating societies: ASPN, Peds Section, AAP. A new ABPNS board member will be elected at the December 2020 ABPNS BOD meeting.

#### **ABPNS Written Examination**

- The ABPNS BOD requests that all those seeking the pediatric ABNS/ABPNS credential take the written examination within one year of their fellowship, and preferably in their fellowship year. The exam is usually held in June.
- This year, the ABPNS will be holding an additional written (online) examination on November 6, 2020, for those seeking the pediatric RFP but who are not currently in fellowships.

#### IN MEMORIAM: RALPH KISTLER

Jack Walker, MD, FAANS

Ralph Kistler, a great friend and supporter of pediatric neurosurgery, passed away quietly at his home on October 18. He was 81 years of age and was surrounded by his family. Ralph was diagnosed with an atypical carcinoid tumor of his left lung in 2014. He had an upper left lobectomy followed by radiation therapy. His last follow-up in September 2019, five years following his original diagnosis, showed no disease. In the spring of this year he began to exhibit balance issues. CT and MRI in September showed multiple brain lesions. He also had metastasis to his liver.

Ralph came to the neurosurgical community in 1990 when he became the vice president of sales for the new PS Medical company. His easy-going manner, knowledge and availability allowed him to help PS Medical become an important part of hydrocephalus management and the market leader in hydrocephalus therapies. He was always available if there were questions of any kind. He had a large role in the transition from PS Medical to Medtronic.

I believe that Ralph played an important part during the early years of pediatric neurosurgery, when we were trying to establish an independent identity. He was always willing to support our meetings, even in the beginning when attendance was quite small. He also supported pediatric neurosurgery around the world, not just here in North America. Colleagues in the ISPN knew and respected him. Ralph's commitment to the hydrocephalus community was also manifest by his service as a member of the Board of Directors of the Hydrocephalus Association.
