As your next Chair of our AANS/CNS Joint Section on Pediatric Neurological Surgery, I have some large shoes to try to fill. The Executive Committee leaders over the past decade have dramatically strengthened and expanded our Section and its activities. Fundamental to our ongoing success is our financial health. As you will see in Dr. Bristol's report, the Section now has substantial cash reserves, despite the challenges of pandemic-related meeting cancellations and market volatility. Our annual meetings—which I view as the raison d'etre of the Section—remain highly attended and engaging. The Executive Council made the decision to transition our meeting management to the CNS last year, after a long and successful partnership with AANS. This resulted in an eminently successful meeting in Washington DC, led by our local hosts Drs Bob Keating and Hasan Syed. Numerous opportunities are now available for our members—at all levels-- to participate in Section activities, ranging from education, research, outreach, administration, diversity, communications, industry partnership and international activity and liaisons, just to name a few. # INTERNATIONAL RELATIONS COMMITTEE

The AANS/CNS Section on Pediatric Neurological Surgery International Relations Committee (IRC) continues to promote the global neurosurgical efforts of its section members.

The successful Annual Section Meeting in Washington DC had a distinct global neurosurgery flair on its first day, including a live international virtual panel of neurosurgeons from Egypt, Singapore and South Africa, a keynote lecture from Ukraine and abstracts on global neurosurgery, diversity and equity in health care and equal access to pediatric surgical care. The first "Best Global Neurosurgical Paper" award was given to Maria Punchak for her work "Presentation, Treatment Outcomes, and Referral Patterns of NTDs in SW Uganda." Furthermore, the meeting also contained a pre-meeting global neurosurgery course (organized by Caitlin Hoffman and Samer Elbabaa) with a half day of talks and discussion with numerous in-person and international virtual attendees. The IRC hopes to expand both of these efforts for next year's meeting.

The IRC is also excited to announce the Sanjiv Bhatia Global Fellowship, which will offer North American residents/fellows the opportunity to participate in a sponsored clinical/research experience hosted at a global institution. We hope to have our first recipients of this award this year. The IRC continues to identify section members who collaborate internationally with the purpose of enlisting them as mentors. ### TREASURER'S REPORT 2023.04.06

The Pediatric Section remains in good financial health. Total net assets as per the last (1/31/2023) financial statement totaled \$1,312,109. This is a decrease from the prior year (\$1,611,634) but continues to reflect a reserve to support an entire annual meeting plus Section activities for around two years without any revenue.

### **Annual Meeting**

The section offered the highest-attended in-person meeting at 459 registrants in Washington, DC. The virtual component was available at a reduced cost to national attendees, and free for international attendees. The expense report for the 2022 Annual Meeting for the AANS/CNS Joint Section in Pediatric Neurological surgery is still being finalized. Initial review reveals certain changes in the post-COVID financial culture of large-scale meetings that will need to be adapted to for the future. Although corporate revenue and registration revenue came in nearly \$20,000 over budget, that did not offset the rate hikes in Audio-visual, Food & Beverage and venue costs. The section is working with the CNS to secure the most favorable possible contracts for future meetings.

### **Long Term Investments**

The Section's long-term investment account has suffered the same fate as other markets, with a loss of \$275,412 to \$817,297. Short-term investments remain stable at \$250,675. The Section's long-term investments are handled via a pooled investment portfolio with the other sections, which allows the sections to get into funds not otherwise available to smaller investors. There is an additional investment with the CNS Foundation of \$250,000 which was matched by the CNS.

### **Honor your Mentor Funds**

As of 1/31/2023, the A. Leland Albright fund has received total pledges of \$59,105 (with \$9,821.71 in investment earnings) and has disbursed \$32,200. The Sanjiv Bhatia fund has pledges of \$53,900 (investment earnings \$6,032.53) and has not yet had any disbursements but has achieved the 50K benchmark required. The interest from this fund will be used for a new global grant in coming years. The Marion "Jack" Walker fund has accumulated \$28,290 (investment loss of \$712.35), also without disbursement.

### **Specific Expenses and Financial Resolutions**

The Section has expanded its commitment toward educational and research missions. Between the Section research awards, the Pediatric Neurosurgical Research & Education Foundation (NREF) Fellowship grant and domestic and international traveling fellowships, and private foundation donations, the section now offers 13 different awards. An ad-hoc committee to explore partnering with industry met in DC this year and initiated productive discussions for engagement. With respect to the renewed interest in gun control measures, the Section supported a Neurosurgical representative (Dr. Jonathan Martin) who attended the ACS Firearm Safety Summit in 2022.

# AMERICAN BOARD OF PEDIATRIC NEUROSURGERY (ABPNS) REPORT — SPRING 2023

### **Officers and ABPNS Directors**

The current Officers of the ABPNS are: Bermans Iskandar – chair and Bruce Kaufman – secretary-treasurer and vice-chair.

The other ABPNS directors are David Gruber, Mark Krieger, Karin Muraszko, Jeffrey Ojemann, Mark Proctor, Shenandoah Robinson, Jodi Smith, Abhaya Kulkarni and our newest member, Ruth Bristol.

### **ABPNS-Eligible Fellowships**

Thirty-three pediatric neurosurgery fellowship programs are accredited by the ACPNF to train Pediatric Neurosurgery fellows. In the 2022/2023 academic year, there are 28 ABPNS-eligible fellows.

### **ABPNS Certification Updates**

The ABPNS is currently only certifying pediatric neurosurgeons by awarding a Recognition of Focused Practice (RFP) in conjunction with the American Board of Neurological Surgery (ABNS) or the Royal College of Physicians and Surgeons of Canada (RCPSC). The RFP is recognized by the American Board of Medical Specialties (ABMS). The RFP requires the neurosurgeon to remain up to date with the requirements of Continuous Certification, regardless of whether you hold a non-time limited certificate from the ABNS.

The usual process for obtaining ABPNS recognition starts with completing a fellowship in pediatric neurosurgery approved by the American Council of Pediatric Neurosurgery Fellowships (ACPNF). Passing the written examination in pediatric neurosurgery (also known as the RFP examination) is also part of the credentialing process for both RCPSC and ABNS candidates. The ABPNS suggests that all those seeking pediatric credentialing take the written examination in the latter part of their fellowship or within one year of fellowship graduation. The ABPNS RFP written examination is currently offered once per year in May.

The next one is scheduled for May 12, 2023 (9 am and 11 am ET).

The final part of obtaining pediatric RFP certification is taking and passing an oral examination in pediatric neurosurgery. The pediatric oral examination can be requested as part of the ABNS oral examination. RCPSC candidates and ABNS diplomates who did not take the pediatric focused version of the ABNS oral examination should apply for a pediatric oral examination through the ABPNS.

For those who have not completed an ACPNF-approved fellowship, or are 10 or more years in a pediatric neurosurgery practice, alternative ABPNS certification pathways exist (refer to ABPNS website <a href="https://abns.org/abpns/">https://abns.org/abpns/</a> for details).

The ABPNS is currently working with the ABNS to streamline the written and oral examination process for all of our candidates, taking advantage of the mechanics and standardizations used by the ABNS.

The ABPNS office is always willing to help with the certification process and assist as we are able. We understand that the process can be confusing, and there are some unique situations.

Please note that the RFP granted under the authorization of the ABMS requires a regular review of the certificate holder's practice to confirm that they continue to have a 'focused practice'. The ABPNS is creating a process for documenting that focused practice. We intend to keep this straightforward and easy to complete.

### **ABPNS Recertification**

Currently, ABPNS diplomates must re-certify every 10 years to remain active, and that recertification process requires the diplomate to apply to the ABPNS, submit a 12-month case log of at least 65 pediatric (age 21 and under) cases and a minimum of 85 total surgical cases in the previous year. The ABPNS Board is working to align the entire process of ABNS Continuous Certification with Re-Certification. We will keep you informed of changes as they occur.

Please continue to follow the Re-Certification process as shown on our website. The ABPNS Board meets twice a year to complete these reviews; applications should be submitted by April 1 for the summer review and by October 1 for the winter review.

### **GUIDELINES COMMITTEE**

David F. Bauer, MD, MPH, Chair, Guidelines Committee

I have been fortunate to work with a stellar group of people on the Pediatric Section Guidelines Committee. Joint Guideline Review Committee members include David Bauer, Taylor Abel, Sarah Jernigan, Brandon Rocque, Jonathan Pindrik, Alex Bier, Laurie Ackerman, Howard Silberstein, Eric Jackson. Chiari Guideline Working Group members include David Bauer, Toba Niazi, Rabia Qaiser, Shobhan Vachhrajani, Eric Jackson, Jeffrey Raskinm, Sarah Jernigan, Jogi Patitisapu, Laurie Ackerman, Cormac Maher, Libby Infinger, Brandon Rocque, Carolyn Quinsey, and Howard Silberstein.

We completed guidelines for the treatment of Chiari I Malformation in winter 2022. The Guideline is divided into three chapters evaluating evidence for diagnosis, treatment and care of patients with Chiari I Malformation. It has been endorsed by the AANS/CNS and will soon be published in *Neurosurgery*.

Brent O'Neil and Angela Price are continuing work on guidelines for Surgical Treatment of Epilepsy with the Stereotactic and Functional section and American Epilepsy Society. The process was on hold during COVID-19, however the AES is regrouping the task force during a March 2023 meeting, and we hope to report on progress in the near future.

We contributed to an update of the Diagnosis of Brain Death Guidelines with AAP and AAN, and these guidelines should be finalized and published soon (first or second quarter 2023).

We submitted a proposal for guidelines for the treatment of tethered cord to PCORI, and this proposal was funded. AHRQ has taken over the task of performing the literature review based on our PICOT questions and inclusion and exclusion criteria. We are forming a working group to draft the recommendations based on the AHRQ findings.

Because we found significant gaps in the literature when completing Chiari Guidelines, we proposed creation Practice Parameters for the treatment of Chiari Malformation, the process will utilize the Modified Delphi Method to answer granular questions about treatment and care of patients with Chiari I Malformation.

Finally, we are updating the 2016 guideline for treatment of positional plagiocephaly. A workgroup has been formed, and work is in process.

### **QUALITY IMPROVEMENT COMMITTEE**

The Quality Improvement (QI) Committee continues to work to promote the role of QI in pediatric neurosurgery. First, the co-chairs of the committee, along with the help of Gabriella Pendola (medical student), George Koutsouras (neurosurgery resident), as well as Dr. Joseph Piatt (quality officer of the Chair's Committee on Planning and Development) and Dr Bruce Kaufman (QI Senior Advisory Committee), were able to publish a manuscript (Current state and future direction of quality improvement in pediatric neurosurgery: a survey of pediatric neurosurgeons) in the Journal of Neurosurgery: Pediatrics in the November 2022 edition. This paper will help disseminate the opinions of the members of the AANS/CNS Section on Pediatric Neurological Surgery on the role of QI in our community.

Second, a subcommittee completed the updates to the QI page on the <u>pedsneurosurgery.org</u> website. A form is now available for members to fill out in which they can share details about active or previous QI initiatives. The QI Committee will then use these forms to showcase

ongoing or previous QI work on the website. Our hope is that these will foster collaboration and inspire the advancement of projects to improve patient care both locally and potentially at multi-institution level.

Third, another subcommittee is making progress on developing a curriculum that will provide education on science of improvement and safety specifically targeted for the pediatric neurosurgery community. The subcommittee members have created content for online modules that will deliver tools and guidance for those interested in learning QI methodology and its implementation. We are currently working on finalizing content and format. We hope to have this content available through the pedsneurosurgery.org website in the future.

As always, the QI committee would like to thank the subcommittee members, as well as Dr Joseph Piatt, and Dr Bruce Kaufman for their continued work and encouragement.

### **TUMOR LIAISON REPORT**

The Executive Committee of the Joint Section on Tumors met in San Francisco, CA, on October 9, 2022. An update on pediatrics-related concerns was provided by Anthony Wang.

- The NCCN released its first pediatric CNS tumor management guidelines. Gerald Grant, Renee Reynolds and Anthony Wang represented neurosurgery in the development of these guidelines. The NCCN is preparing management guidelines for medulloblastoma. Renee Reynolds and Anthony Wang are representing neurosurgery in the development of these guidelines.
- The NCI Cancer Moonshot Research Initiatives include pediatric immunotherapy discovery and development, and research on the major drivers of childhood cancers with focus on fusion oncoproteins. This collaborative network awarded 7 U01, 2 U54, and 1 UM1 grants under this initiative. Its goal is identifying and advancing preclinical immunotherapy research for children and adolescents with CNS cancer.

- Two specifically pediatric CNS tumor consortia are currently running clinical trials in the United States (PNOC and Connect), as well as two broader pediatric oncology consortia (COG and SIOPE). Each has opened new pediatric neuro-oncology trials in the past year.
- Pediatric and AYA cancers, as well as brain tumors, continue to receive priority status in research funding from the DOD CDMRP, and this is expected to continue when the next funding priority determination is released.

The field of pediatric neuro-oncology continues to expand at a rapid pace even relative to neuro-oncology in general, and pediatric neurosurgeons with interest and expertise in clinical trials, translational development, pharmaceutical discovery, and data science surrounding CNS tumors are needed to help drive the clinical aspects of the field forward. We continue to advocate for separate pediatric/adolescent/young adult tumor consideration in resource allocation and prioritization, due to the relative rarity of these conditions, but the potentially greater impact of these initiatives.

### **EDUCATION COMMITTEE**

### 1. Webinar

The Lectures and Webinar Committee continues to run the virtual conference every-other-month, featuring a 30-minute educational talk by an invited guest lecturer, followed by a 30-minute case presentation/Q&A session hosted by a panel of junior faculty, fellows and residents.

The last conference featured Dr. John "Jay" Wellons discussing "The Brachial Plexus – Breaking Down the Workup and Surgical Intervention to Understandable Steps." It is hosted by Johns Hopkins All Children's Hospital and moderated by Dr. Matthew Smyth, chief of Pediatric Neurosurgery.

These provide detailed, state-of-the-art pediatric neurosurgical educational content to fellows, residents, students and others. The next webinar is scheduled for March 21 and Dr. Smyth will be discussing the surgical evaluation of a child with epilepsy, hosted by UT Houston.

### 2. Podcasts

The Podcast Subcommittee. We've released several new Insights in Pediatric Neurosurgery podcasts, including the most recent episodes interviewing Dr. Jonathan Martin about gun violence and the role of pediatric neurosurgeons in firearm safety and prevention, as firearms are now the leading cause of death in children, as well as fellowship training in pediatric neurosurgery. 

### SPRING 2023 AANS/CNS DRUGS AND DEVICES COMMITTEE UPDATES

Brian W. Hanak, MD, and Leopold Arko IV, MD, MS, *Pediatric Section Liaisons* 

The AANS/CNS Drugs and Devices Committee is bringing pediatric neurosurgery to the forefront in ongoing efforts the to ensure we have critical supplies in the face of ever-changing supply chain landscapes. Broader general efforts to strengthen ties with our orthopedic surgery colleagues in lobbying efforts have a strong pediatric focus. There are also great upcoming opportunities to learn more about the process of getting novel device ideas approved by the FDA. The committee is continuing to raise awareness about CMS Open Payments dispute periods among all neurosurgeons.

- On Jan. 31, 2023, AANS/CNS Drugs and Devices Committee Chairman, Dr. Joshua M. Rosenow submitted comments to the FDA to help the agency develop a critical medical device list. The comments were based on a list from committee members of critical medical products used by neurosurgeons that were at potential risk for shortages. However, if additional critical device/supply resources arise in your region that are not listed below please contact Leo (arko1l@cmich.edu) for vascular/endovascular or Brian (bhanak@llu.edu) for hydrocephalus/other so we can make sure these are included in ongoing discussions. Items identified by the committee include:
  - Cerebrospinal fluid shunts, external ventricular drains
  - · Local anesthetics
  - Disposables for OR tools such as drill bits for cranial and spinal surgery, ultrasonic aspirator tips, skull clamp pins
  - Titanium clips for neurovascular surgery
  - Hemostatic products such as thrombin, collagen sponge, collagen foam, dural sealants
  - Surgical drapes for patients and microscopes
  - Raw materials for wires/stents such as nitinol
  - Dural substitutes
  - Disposable neuro-navigation supplies (patient trackers, navigation wands)
  - Intracranial pressure monitors

- Increased collaboration with the American Academy of Orthopaedic Surgery (AAOS) to address shared concerns with pediatric device approval/regulation/innovation:
  - The AANS/CNS Drugs and Devices Committee met with representatives from the AAOS and the Scoliosis Research Society (SRS) to discuss common issues of device regulation on Nov. 27, 2022.
  - Dr. John Ratliff will be attending an AAOS sponsored meeting, the 10th annual Kids' Forum, focused on pediatric device issues on March 10, 2023. Dr. Rosenow, Dr. Paul M. Arnold, Dr. Brian Hanak, and Dr. Leopold Arko participated in a Feb. 27, 2023 meeting with Dr. Ratliff to assist him in preparing for his presentation on device issues unique to pediatric neurosurgery
- Dr. Rosenow will be hosting a luncheon seminar on FDA issues during the CNS meeting in Washington, DC on Monday, Sept. 11, 2023.
- Dr. Rosenow has reached out to Dr. Christopher Loftus, acting director of the FDA Office of Neurological and Physical Medicine Devices, to design a series of webinars for neurosurgeons on FDA issues. A conference call is planned in March 2023 to discuss the first webinar tentatively scheduled for May/June 2023, which will provide an overview of the FDA process by FDA staff. Subsequent webinars are intended to highlight neurosurgeon innovators and their experiences with bringing their inventions to the agency.
- CMS Open Payments: 2022 data will be published in June 2023
  - On Dec 15, 2022, the AANS/CNS Washington Office sent a notice to 6,000 neurosurgeons to remind them about the annual opportunity to check existing Open Payments data. The 2021 Open Payments published records were available for review and dispute through Dec. 31, 2022.
  - In Jan 2023, the agency updated or "refreshed" data from 2015 to 2021 to reflect corrections made since the June 2022 publication.
  - 2022 Data: Manufacturers have until March 31, 2023 to report 2022 payments to CMS. Annual Review and Dispute Period for 2022 data is April 1 - May 15, 2023. Thecommittee will again be publicizing this review period and encouraging members of AANS/CNS to check their data for inaccuracies with:
    - Another email notice will go out this spring
    - Plans to include discussion of this review period in the "It's Not Brain Surgery" podcast hosted by Dr. Paul Camarata
    - NOTE: The planned CNS meeting luncheon seminar on FDA issues will also include representatives from CMS to address educational efforts on the Open Payments program
